

ORDINANCE NO. 533

AN ORDINANCE OF THE VILLAGE OF POTTER, NEBRASKA, TO AMEND THE VILLAGE OF POTTER MUNICIPAL CODE SECTION 51.08 PERTAINING TO GARBAGE SERVICE RATES; TO AMEND SECTION 52.09 PERTAINING TO WATER SERVICE RATES; TO AMEND THE TITLE OF SECTION 53.11 FROM "RATE SETTING" TO "SEWER SERVICE RATES" AND TO AMEND SECTION 53.11 PERTAINING TO SEWER SERVICE RATES; TO REPEAL CONFLICTING ORDINANCES AND SECTIONS; AND TO PROVIDE AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CHAIRMAN AND BOARD OF TRUSTEES OF THE VILLAGE OF POTTER, NEBRASKA:

Section 1. That §51.08 be amended to read as follows:

§51.08 GARBAGE SERVICE RATES.

Effective October 1, 2025, the following garbage service rates shall be applicable on a monthly billing basis to all customers. Garbage is collected at least once per week, but it may be removed more often and at such times as the village directs and deems necessary. Each apartment, mobile home, or condominium unit shall be considered as a separate residential unit.

Residential Rates:	
Within Village Limits	\$35.74
Outside of the Village Limits	\$40.38
Commercial Rates:	
Small Business (Shared Dumpster)	\$40.38
Commercial (1 Dumpster)	\$51.51
Heavy Commercial (2 Dumpsters)	\$95.52
Per Each Requested Extra Dump	\$30.00
Schools	\$361.33

Section 2. That §52.09 be amended to read as follows:

§ 52.09 WATER SERVICE RATES.

Effective October 1, 2025, the following water service rates shall be applicable to all customer, either within or outside of the municipal limits of the village, connected to the municipal water system on a monthly billing basis. Each apartment, mobile home, or condominium unit shall be considered as a separate residential unit.

Residential	\$61.00
Commercial	\$61.00
Outside City Limits	\$100.69
Schools	\$850.87

Section 3. That §53.11 be amended to read as follows:

§53.11 SEWER SERVICE RATES.


Effective October 1, 2025, the following sewer service rates shall be applicable to all customer, either within or outside of the municipal limits of the village, connected to the municipal sewer system on a monthly billing basis. Each apartment, mobile home, or condominium unit shall be considered as a separate residential unit.


Residential	\$22.05
Commercial	\$22.05
Schools	\$380.43

Section 4. That any other ordinance or section passed and approved prior to the passage, approval, and publication of this ordinance and in conflict with these provisions of this ordinance, is hereby repealed.


Section 5. This ordinance shall go into force and effect from and after its passage, approval and publication or posting as required by law.
